# PREFACE: THE DESTRUCTION PROCESS

More than 80% of civil forfeitures by default - No money for lawyer

 This book uses a case study to explore the process by which society can destroy an ordinary group of people. In the United States the process has already been applied against Japanese-Americans and against African-Americans. Both those examples prove that the process can be halted when a society awakens from a delusion in which a group of ordinary people is targeted for destruction.

That is fortunate because American history provides yet one more example of ordinary people targeted for destruction. That example was underway while this book was written, and indeed is the reason why this book was written.

In the United States during the 1990s drug users were targeted for destruction. I believe the effort to be more than a mistake; I believe it to be a catastrophe. Not everyone agrees with me. Indeed, the war against drug users enjoys such wide popular support that many Americans intent on saving their country from drug users may have difficulty believing anyone could sincerely oppose that war. Attitudes toward a war, however, can depend on the perspective from which it is viewed. Two motion pictures illustrate the power of perspective. In 1934 Leni Riefenstahl directed *Triumph of the Will*. A half century later Oliver Stone directed *Salvador*. Both films treat the same subject: People convinced of their superiority rescue a country threatened from within. One film presents the rescuers' perspective. The other presents the rescue as seen by those on the

I write from the viewpoint of those on the receiving end. I tell a story about people who want to destroy their neighbors. These people are not monsters. In every way imaginable they are ordinary persons. But they have become entwined in a destruction process at great cost to themselves and their society.

The destruction process is basically the same anywhere. Certain things must be done in order to eliminate a large group of persons from society. On the facing page is a diagram inspired by Raul Hilberg's monumental study of the destruction process as applied to the Holocaust. Elements of destruction can be visualized as a chain. Once the targeted group is identified, members can be ostracized from community life through boycott of social and business relations (including job dismissals), and through revocation of legal rights. The next link in the chain of destruction is property confiscation, followed by concentration of the group's members into geographical localities. The final element of destruction is annihilation, by prevention of birth and infliction of death. Birth can be prevented through regulations affecting marriage and childbearing, including compulsory contraception and sterilization. Death can be inflicted by indirect or direct means. Indirect means include withholding of medical care. Direct means include death squads and central killing operations (camps).

Each link in the chain will be examined by a chapter in this book. When this book was written, the identification, ostracism, and property confiscation aspects of the war on drug users were well established and proceeding smoothly. The concentration element was at mid-point, and the annihilation element had begun. The latter two elements were in "prototype" stage rather than "full production," but necessary mechanisms were in place. There was no reason to doubt that full production could be reached. And we know the destruction process can accelerate suddenly.

Americans who experience the drug war as mental Muzak may be startled to learn that the destruction process has progressed so far. Few important drug dealers, let alone "narcoterrorist kingpins," are being processed. The majority of victims are ordinary people minding their own business.

Elsewhere I have argued that mass murder is probable once a society decides to eliminate a group of ordinary people, as was the case in Nazi Germany. The process allowing such an outcome in the war against drug users is underway. That is one reason why I feel uneasy about the growing popular support for eliminating drug users in America. Nonetheless, although the destruction process can lead to mass murder, the process can be abandoned. Its fulfillment is not inevitable.

I hope this book will help illuminate what drug warriors are doing and why their activity threatens all Americans.

If we wish to destroy drug users we must detect them. In the United States during the 1990s, characteristics of drug users were popularly considered so blatant as to make detection simple. But in this chapter we shall find that characteristics of drug users are not blatant at all. Indeed, in most cases their behavior is so indistinguishable from that of other citizens that police are often unable to detect a drug user without removing and analyzing part of the person's body. Such means of detection implies that popular images of drug users are stereotypical instead of accurate. Decades of scientific research verify that implication. Drug users look and act like everyone else.

HOW SCIENCE DESCRIBES DRUG USERS  
Legal status of a drug has little relation to its effects. Alcohol is one of the most powerful intoxicants. Yet it is legally available to adults, where the far milder drug marijuana is forbidden.
