I graduated from college magna cum laude and got two more university degrees, I taught kindergarten for 33 years, was elected to local government five times and then founded the Safer Michigan Coalition, which has had a hand in 24 out of the 25 local cannabis law reform victories across Michigan since 2004. And I can still swim a mile in an hour.

We have now learned what happens when marijuana is legalized – teen use goes down, jobs and business activity go up, there are less crimes of violence, especially murder, and less death on the roads.

Significant revenue goes to government, (and governments are already addicted). Opiate overdoses drop 25%.

Welcome to the great city of Ann Arbor, the first city in the world to legalize cannabis – with the five dollar fine in 1972. In 2004 I left my kindergarten to organize medical marijuana in Ann Arbor and win with more than 74% in favor.

And welcome to 2017, the year that we firmly set cannabis legalization in motion for November of 2018.

This is the time of maximum suspense. Within about 10 days the Mlegalize campaign and the Regulate Marijuana Like Alcohol campaign are either going to come together and give us a united proposal for 2018, or split apart and we will have two proposals and much bitterness and acrimony.

I put together MIlegalize at the beginning and worked my guts out and sacrificed my time and health and so much money. I quit MIlegalize because I thought that they were more interested in preserving their own project and leadership than in winning legalization. I hope I am wrong.

Now I am totally on board with the <u>Coalition to Regulate Marijuana</u> <u>Like Alcohol</u> (CRMLA) because I am sure that they can win legalization, and they are good people.

Please remember that any law is not the last word on cannabis policy. Cannabis policy will continue to evolve as voters see that there is nothing to fear and much to be gained. After legalization we will keep on pushing until we get "free, legal, backyard marijuana".

We have worked and waited and suffered for too long to screw this up. We have seen our people arrested, and fined, and jailed, their property confiscated, their children taken away, student loans prevented, housing denied, drivers licenses is taken away, and promising lives wrecked.

We will have legalization in 2018, and I am not Pollyanna. The only question is whether we are united or divided. We could fairly easily sail to victory in 2018 under the umbrella of the Coalition to Regulate Marijuana Like Alcohol, and leave a few questions for the future, OR we can have a bitter battle, harsh and bruising, with brother against brother and friend against friend. It is my greatest hope that our two legalization groups can unite. Personal ego can prevent that unity now - and unity or no unity I

will do whatever is necessary to win. Our absolute duty is to win.

We will bring our healing miracle plant to this desperate planet.
