optional On Friday May 7 petitions containing nearly 7000 signatures will be turned in to the Clerk of the city of Ann Arbor in order to put Medical Marijuana on the Ann Arbor Ballot in November. 4170 valid signatures are legally required.

Marijuana (properly called Cannabis) has been an important medicine for thousands of years. It was reintroduced into Western medicine around 1850 as tincture of cannabis and became a staple of American and European medical treatment. Queen Victoria used it for a variety of ailments; Mrs. Lincoln was given it when President Lincoln was shot. Cannabis formulas were used with the tiniest infants and the oldest grannies.

Cannabis keeps people alive who otherwise could not keep food down, allowing cancer and AIDS patients to survive. It lets people with Arthritis and Multiple Sclerosis move more freely with less pain. Cannabis is a proven painkiller that you can't overdose on or get addicted to. It successfully treats Glaucoma, insomnia, migraine headaches, spasticity and seizures, and many stress-based ailments. It can often help with depression, epilepsy, aggression and hostility, and withdrawal from addictions. My personal problem was stomach pain; I think cannabis kept me alive during 1968.

Decisions about medical care must be left to doctors and patients, particularly with a substance that has no known lethal dose. Our Bill of Rights, our concepts of federalism and separation of powers, our relations between citizens and law enforcement, and the faith of citizens in our democratic system are being destroyed to stamp out our earths threatened most useful plant.

The savage cultural war on cannabis has no justification in science or public health. Sick people must be exempted from this harassment. Why would we spend scarce tax dollars to keep medicine from suffering people? We can stop it in Ann Arbor.
