- D) To end the atrocity of Marijuana prohibition by taxing and regulating cannabis like we do alcohol.
- E) To make local governments to do good things. To stop local government from doing bad things.

III) BE THE "WATCHDOG" OF YOUR LOCAL GOVERNMENT, MEDIA, AND LAW ENFORCEMENT

Go to your local government meetings, even their work sessions. Make friends, and make it clear what your issue is. Tell them you are considering a run for office yourself. Write letters and make calls to local media when an important issue comes up.

When you know your local politics you will be among the first to know when a good or a bad policy is being hatched. Immediately try to "lobby" with you best contacts in City government. Use your contacts in local media to get the facts out ("framed" the way you choose; with your own "spin" on it.) Praise local officials for steps forward and make sure they are implemented. Condemn them for oppressive or restrictive plans. Get bad ideas changed before they are even enacted.

Nowadays you can check all agendas and minutes of local governments on the web, so you can keep track of what is happening and attend the meetings that are most important.

Dale comment, "It takes a special kind of OCD to keep close track of local Government"

Don't be shy. Publicize the facts you unearth. RUN FOR LOCAL POLITICAL OFFICE - OR FIND GOOD CANDIDATES AND HELP GET THEM ELECTED! You can do it! I was elected to 5 four year terms in local township government. If you are going to the meetings anyway it is much effective (and fun) if you have a vote.

IV) FORCE GOOD CHANGES WITHIN A MICHIGAN CITY

If you live in a County or a Township you have no electoral mechanism other than voting to force a change that you want.

Michigan CITIES, however, are governed by "The Home Rule City Act", which gives local citizens of CITIES the right to change a city ordinance or revise City Charter through an initiative and referendum process. If you get enough signatures on a properly written petition the city has no choice but to adopt your proposed changes or put them on the ballot.

Step 1 - Review (google) the Michigan Home Rule City Act; study section 117.21 through 117.25

Step 2 – Review the a) City Charter and b) City Ordinances. Follow all directions and make sure your new ordinance or Charter revision language fits perfectly into the current city charter or ordinance book. Have your work checked by an attorney who knows election law.

We used this process to get the 5 local victories which led up to our new statewide Medical

Marijuana law.

Here are a coupled signs from out victories

Most major new local government initiatives require funds, and to get new tax money often requires a vote. IT IS VERY EASY TO KILL ANY NEW LOCAL GOVERNMENT PROGRAM THAT REQUIRES NEW TAXES. For instance, what if your town wanted to build a huge new jail – to house people like you and your friends. You can organize a small group (if possible), get your views out to the media, put up lots of well made signs and kill it. JUST SAY NO!

If your local city passes an **ordinance** you don't like, such as a restriction on Medical Marijuana, you can **force it to be put before a vote of the people through the initiative and referendum process** (which is outlined in your city charter, which is on the web).

VI) USE DIRECT ACTION - "TAKE TO THE STREETS".

Maximize publicity about the issue and the demonstration you will be holding (at City Hall, the Jail, the newspaper, etc). Local officeholders and elected judges pay very close attention to what they read in the paper and to public opinion. A well publicized demonstration with a clear message can have much more power than you think. You only need 4 people with good signs to have a good demonstration. Four people, with good signs and good publicity to the media, can be more effective than having 400 people with no publicity. Make your own video of the event and post it where you can.

EXAMPLES a)Gersh – self defense, b)Derek Copp- stop shooting students,c) the "74%" demonstration following Hash Bash –demand to implement Medical Marijuana in Ann Arbor.

(II) WHAT IS NEXT IN MICHIGAN POLITICALLY, HOW DO WE GET TOTAL VICTORY?

Local Michigan activists won victories for Medical Marijuana in 5 Michigan cities; and now we have Medical Marijuana statewide.

In the Nov. 2010 election local Michigan activists plan to win Lowest Law Enforcement Priority (LEEP) initiatives in 5 Michigan cities on the same day (to "pave the way" for "tax and regulate" (legalization). Cities under consideration so far include Flint, Mt. Pleasant, Kalamazoo, Ypsilanti, and Ferndale.

An "LLEP" mandates that a city shall make "possession or use on private property of up to 1.1 ounces of Marijuana by adults the lowest law enforcement priority of the city". Winning a LLEP

Prisoners of the Drug War?

"I want to know exactly what happens to the seven hundred people arrested annually in Washtenaw County for pot—and what happens to other Drug War arrestees in this county."

The person doing the asking is Scio Township trustee Chuck Ream. Soft voiced and amiable -he's a retired kindergarten teacher-Ream is nonetheless a force to be reckoned with in county politics. Two years ago he led the referendum that legalized "medical marijuana" in Ann Arbor. Soon after, he mobilized opposition that killed the county's \$314 million criminal justice millage. Ream's objection: most of the money would go to build and operate 200 additional cells at the county jail-cells that authorities said would be used to ease overcrowding but that he feared would be filled with busted potheads.

According to local police officers and prosecutors, though, it takes a real effort to get arrested for marijuana possession in Washtenaw County—and it's all but impossible to be sent to jail for it. "In the last twelve years, I can't think of a time when's sent somebody to jail for [possessing a small quantity of] marijuana," says lieutenant Garth Burnside of LAWNET, the consortium of law enforcement agencies that deals with the county's narcotics crimes. "If we make a bust [on a dealer] and someone's there buying, we usually just tell them to leave."

Asked how many people his office has prosecuted and jailed for pot, Steve Hiller, the county's deputy chief assistant prosecuting attorney, responds, "Do we prosecute? Yes, we do. Do they go to jail? No not for that, anyway. It's not unusual for them to get probation and go through a rehab program. And if they stay clean through probation and complete the program, they can have the conviction wiped off their record."

Asked how many prisoners he has locked up over marijuana, Kirk Filsinger, the commander of the Washtenaw County Jail, replies, "None. I can't remember the last time we had one." Filsinger says most of the prisoners are there either for repeated property crimes (usually theft from a building, usually from students) or for repeated violent crimes (usually domestic assault, usually of wives, girlfriends, or kids). In other words, the jail is chronically overcrowded not with busted potheads but with thieves and wife beaters.

Yet there are prisoners in the county jail whose offense is listed as marijuana possession. So if no one's arresting users, how did they get there? To find out, the Observer examined seven marijuana possession cases in 14B District Court: four folks who've actually done jail time and three folks who haven't done time but might yet if they don't mend their ways.

There were five males and two females, so four blacks and three whites, and they were all between eighteen and twenty-three. Five still lived at home with their parents, three in Ypsilanti and two in Ann Arbor. One had driven in from Westland to visit friends, and one had moved out to Belleville after conviction. Most didn't own their own cars or have steady jobs.

Those who did worked at fast-food joints making about \$200 a week.

All seven were originally charged with possession plus something else: possession plus intent to deliver, possession plus reckless driving, possession plus driving with a revoked license. In every case, all other charges were dropped, and the conviction or guilty plea was for possession only, a misdemeanor under state law. The judges followed sentencing guidelines and put all seven on probation: reporting to a probation officer, submitting to random drug testing, and completing a rehabilitation program. Occasionally some form of community service was included—washing police cars, for example.

All seven consistently failed to meet the terms of their probations. Most just stopped showing up, although one did call to say he wasn't coming anymore because he found probation too harsh. The judges

then issued warrants, which eventually led to another round of probation hearings. When four of the seven failed probation for the second or sometimes third time, they were sent to the county jail to serve between 90 and 365 days—with the understanding they'd be released when they completed rehab.

None of the four served a full sentence: because the jail is overcrowded, they were all released early. And with the jail full of thieves and wife beaters, the odds are preity slim that the four for anyone else convicted of marijuana possession in Washtenaw County—will ever do more jail time.
