

sature of Complaint:

At approximately 2:00 p.m. this date received a telephone call from Lt. Com. Smith, Navy, who was working as a recruiting officer and had a table set up in the University Student Center Lobby. He advised that a short time ago a young man, described as twentyish, tall and slim, wearing a beard and dirty levis, had come up to the table and picked up a large amount of their brochures and carried them over and dumped them into a wastebasket. That they had had some words with the young man, that the young man had advised them his name was Charles Ream and that he was a student at Western Michigan University. Lt. Com. Smith wished to know if we were going to allow this sort of thing to go on. Lt. Com. Smith was advised that plainclothes officers would be in the building in a very short time and would attempt to make an investigation.

Mr. Robert Wirbel then called Dean Donnelly, who together with Charles Stroup, met Mr. Wirbel, myself and Sgt. Smith in the Student Center. Mr. Wirbel and Dean Donnelly then talked to Dr. Griffeth.

There was no disorder of any kind when plainclothes officers arrived. Sgt. Smith then spent the rest of the afternoon in the building until the recruiting officers left at about 4:00 p.m.
