
Subject: MINORML-TALK: EMERGENCY NEWS ON GREG FRANCISCO!!

Dear Friends & Fellow Activists,

Greg's wife, Amy just called me distraught over the fact that Greg was taken from their home at lam this morning, arrested for possession. This is from a drug dog search that was conducted at his school (Greg was a teacher) awhile back and they claimed that they found a stem and edge of a rolling paper (burnt) in his truck and, sent it to the lab for testing.

They have him in a holding tank, will not let her communicate with him, and has set his bond at \$5,000 which they do not have.

I gave her Matt Abel's number to call for legal advice and she asked me to put the word out on computer as to what has happened.

Greg is one of us, a founder of MINORML, and if anyone reading this can help with advice, funds, or just prayers (Greg & Amy are Christians), your help would be most welcomed.
