IT FEELS GREAT TO FINALLY BE ABLE TO STAND HERE AND SPEAK THE TRUTH.

TO SAY THAT MARIJUANA (CANNABIS ACTUALLY) IS NOT MEDICINE IS LIKE SAYING WATER ISN'T WET. MEDICINE IS WHAT CANNABIS IS, FOR PHYSICAL, MENTAL, SPIRITUAL, AND EXISTENTIAL COMFORT.

CANNABIS HAS BEEN USED BY PEOPLE AS MEDICINE SINCE PREHISTORY, AND IS PROMINENTLY MENTIONED IN THE VERY EARLIEST CHINESE, INDIAN, AND ARABIC MEDICAL WRITINGS".

QUEEN VICTORIA OF ENGLAND, WHO WAS NOT A HIPPIE, USED CANNABIS MEDICINE FOR DECADES FOR MENSTRUAL CRAMPS, MIGRAINES, AND INSOMNIA. HER PHYSICIAN CALLED IT "ONE OF THE MOST VALUABLE MEDICINES WE POSSESS".

IT IS SO IMPORTANT FOR EVERYONE TO RECOGNIZE THAT CANNABIS MEDICINE ALREADY HAS BEEN VERY HEAVILY AND SUCCESSFULLY USED IN THE UNITED STATES. BETWEEN 1850 AND 1900 IT WAS PROBABLY THE MOST COMMON INGREDIENT IN AMERICAN MEDICINES. MRS. LINCOLN WAS GIVEN CANNABIS FOR HER NERVES WHEN PRESIDENT LINCOLN WAS SHOT.

THE AMERICAN MEDICAL ASSOCIATION FOUGHT HARD IN 1937 TO KEEP CANNABIS MEDICINE LEGAL; BECAUSE DOCTORS KNEW THERE WERE TIMES WHEN NOTHING ELSE WORKED.

CANNABIS HAS BEEN SHOWN TO HELP SIGNIFICANTLY WITH NAUSEA, APPETITE LOSS AND WEIGHT LOSS. IT CAN HELP PEOPLE KEEP ENOUGH FOOD DOWN TO LIVE THROUGH CANCER CHEMOTHERAPY.

CANNABIS SUCESSFULLY TREATS PAIN OF ANY KIND, AND CAN BE USED IN CONJUNCTION WITH OPIATES TO SUPPLEMENT PAIN TREATMENT. THE TRUTH IS THAT, UNLESS YOU ARE TRYING TO STUDY FOR A TEST, THERE IS NO SIGNIFICANT HARM FROM USING MARIJUANA. THIS HAS BEEN THE CONCLUSION OF EVERY MAJOR NATIONAL COMMISSION AND EVERY LONGITUDINAL STUDY OF CANNABIS USERS.

THE EDITORS "THE LANCET", A PRESTIGIOUS PEER REVIEWED BRITISH MEDICAL JOURNAL, THOROUGHLY REVIEWED CANNABIS RESEARCH AND CONCLUDED - "THE SMOKING OF CANNABIS, EVEN LONG TERM, IS NOT HARMFUL TO HEALTH". THAT IS THE SCIENTIFIC FACT. ANYONE WHO PRESUMES TO BADMOUTH CANNABIS IS MAKING A FOOL OF THEMSELVES.

DRUG CZAR MCCAFFERY’S INSTITUTE OF MEDICINE STUDY AFFIRMED THAT CANNABIS WAS USEFUL MEDICINE, AND THE FEDERAL ATTACKS ON PATIENTS AND CAREGIVERS ONLY INTENSIFIED.
