- 4. A limited number of apartments and condominiums should be built. They should be restricted to the "Jackson Road Corridor" and within the present "sewer district"
- 5. Farming should be allowed to flourish and encouraged in the township.
- 6. We will draft and lobby for an ordinance which will mandate a limit on the Scio Township growth rate.
- 7. We will support a slate of candidates in the crucial August 1988 elections (there may not be much left to subdivide by 1992).

We are facing a group of smart, well-financed developers who will be very aggressive. They have plenty of time to influence our local officials and they have expensive and intelligent lawyers. Without a strong citizens organization, our township will soon look like Southfield or Troy. Please do not ignore this situation now or you may regret it in the future. 

WE NEED THE BOUNDARIES OF THE SEWER DISTRICT ENFORCED Sewer service boundaries have been widened much too far already. The sewer will bring unacceptably high densities wherever it penetrates.

WE NEED A MINIMUM AVERAGE OF ONE ACRE PER HOME OUTSIDE OF THE SEWER DISTRICT

WE NEED TOWNSHIP TAXES KEPT LOW

WE WILL ENCOURAGE ONLY THE HIGHEST QUALITY, most creative and attractive land uses in every category. We aim to take the time to pick and choose in order to create an atmosphere for the best quality of life.

SCIO TOWNSHIP IS ONE OF THE MOST DESIRABLE LOCATIONS IN THE U. S. AT THIS TIME An unending stream of developers is now lining up for approval. clean air, quiet, and we ENJOY it. We don't wait in a line of cars to turn every corner.

Many of us made detailed investigations before we bought our homes. We believed land use plans and zoning requirements would be enforced - not thrown out the window when the first big outside developer came along.

YOU CAN'T AFFORD NOT TO BE THERE when the huge (260 acres) "Liberty Farms" development proposal comes before the Scio Township Planning Commission on OCTOBER 13. This development covers most of the area between Park, Liberty, and Zeeb roads.

At the meeting MAYBE YOU'D LIKE TO COMMENT ON:

* The disruption that 241 condos and 52 units of duplexes will cause to our traffic, our crime (basically non-existent now), our schools, and our quality of life.

* The 86 homesites that are planned with a truely urban density of 4 houses per acre. (Compare this with what you live on now...try to imagine how incredibly crowded it will be!)

* The COMMERCIAL AREA which is planned to be right in the middle of this - with apartments on the second floor of the stores.

* The great number of other home sites, where lot size requirements would be cut to either 1/2 or 1/5 of present requirements.

* The paving over and dredging of wetlands, destruction of wildlife habitat, and an old cemetery.

* That Scio Township is "giving away the store", approving development after development, recently totalling thousands of units. No Scio citizens should be complacent. No part of this township will be off limits to urban sprawl if the present trend continues.

* The fact that many of us received no proper notification of the initial rezoning meeting.

* The fact that the "sewer district" never was planned to go south to Liberty Rd. and that Ann Arbor sewage treatment plant may not have the capacity to serve this development (not to mention others!)

* The new access roads out to Liberty, Zeeb, and Park roads and an estimated 4000 additional car

trips on these roads per day.

* The possible conflicts of interest of some of the officials involved.

* The high taxes and "Empire Building" tendencies we have in local government.

* The incredible truth that after a developer secures a zoning change on the basis of a bunch of pretty drawings HE CAN THEN LEGALLY TURN AROUND AND SUBMIT WHATEVER ACTUAL SITE PLAN HE WANTS TO as long as the general requirements of the new zoning are met. In Scio Township we have no legal way to make the developer keep his initial promises.

IF WE HAD WANTED THE URBAN DENSITY OF THE WEST SIDE OF ANN ARBOR WE WOULD LIVE THERE!!!
